As data over the last three years was impacted by the pandemic in various ways, the NJDOE recommends caution in comparing data from year to year.

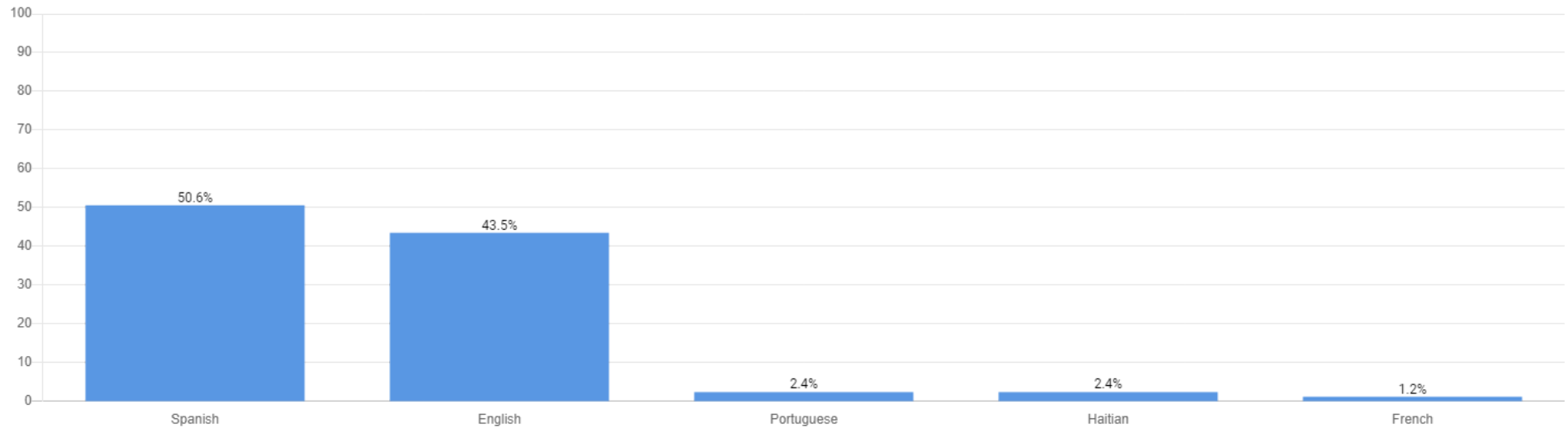

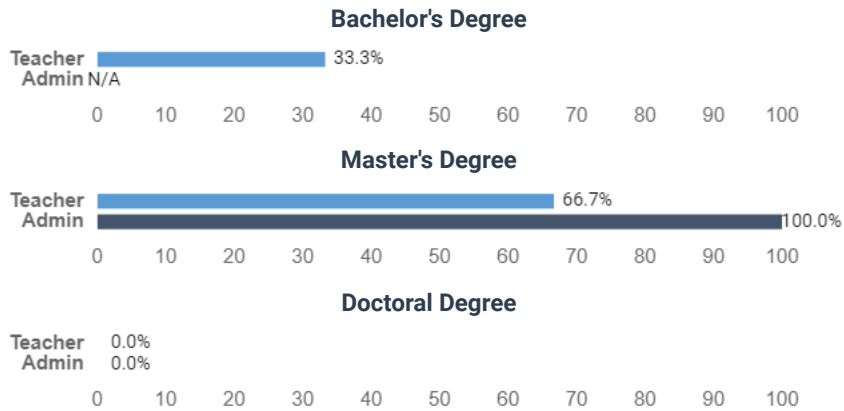
