QUESTION What does Affirmative Action Mean?

ANSWER The Union County Educational Services Commission guarantees each student equal educational opportunities regardless of race, color, creed, religion, gender, age, affectional or sexual orientation, ancestry, national origin, disability, marital or economic status and does not discriminate in the admissions, access and/or treatment of its programs, activities and vocational opportunities.

QUESTION Does the UCESC have a policy and regulations regarding Affirmative Action?

ANSWER Yes. Please contact District Affirmative Action/504 Officer John Marquet at (908) 233-9366 x 3002 to obtain copies of the policy and procedures regarding Affirmative Action. The policy can also be obtained in each school/program.

QUESTION What should my child do if he or she is the victim of bias or discrimination while attending school?

ANSWER A professional staff member in each school is identified as the Affirmative Action Officer. Please immediately contact your child's school to report all concerns of bias.

QUESTION Who is the Affirmative Action Officer for the UCESC?

ANSWER The Affirmative Action/Public 504 Officer for all programs operated by the Commission is Mr. John Marquet. All inquiries and correspondence should be directed to Hillcrest Academy, 2630 Plainfield Avenue, Scotch Plains New Jersey 07076 or (908) 233-9366 x 3002.

QUESTION What do I do to file a complaint?

ANSWER Please contact the District Affirmative Action Officer at the listed address or telephone number to obtain a grievance form or file a written complaint.

QUESTION What happens after I file a complaint?

ANSWER There are several steps involved in the investigation of an Affirmative Action complaint:

Step 1: The District Affirmative Action Officer conducts a comprehensive investigation and provides a written notice of resolution.

Step 2: If you feel that your complaint has not been resolved to your satisfaction, you may refer the issue to the Superintendent for further investigation.

Step 3: You may appeal the decision of the Superintendent by submitting written notice to the UCESC Board of Directors.

Step 4: If you are not satisfied with the decision of the UCESC Board of Directors, you may file a formal complaint with the Office of Civil Rights:
